RULES:

1. Contestants will be entered and judged as a couple (girl & boy).
2. Contestants will appear in "age appropriate attire".
3. All contestants must be a resident of Lincoln County. (Parents may be asked to show proof)
4. Contestants must be 5 years of age and not 8 years by June 30 of pageant year.
5. Contestants must be accompanied by an adult to the location of the contest.
6. Each couple will have a 2 minute interview off stage with judges before pageant and then asked additional question on stage.
7. The contestants must be on location by your assigned interview time starting at 5:00 p.m.
8. Deadline for entry form and \$20.00 entry fee is Thursday morning at practice.
9. Winners consisting of the couple will be expected to enter the State Fair Contest in Louisville, which will be held on August 17, 2016.
10. Each winner will receive a trophy, sash, & \$25.00 cash award.
11. Each child will receive a trophy and fair ribbon.
12. Any contestants that have competed at the professional level will be considered ineligible for this pageant. (Professional defined as follows: any contestant that has performed or competed for monetary gain in anything other than amateur.)
13. Entry fee for winners to the State Fair Contest will be paid for by the Lincoln County Fair Board. All other expenses will be the responsibility of the parents. Cash awards will be given by the State Fair and Kentucky Association of Fairs at the State Contest.
14. Contestants are required to attend 10 a.m. practice on Thursday July 6, 2017. Contestants may pre-register at the Lincoln Co. Extension Office by July 3, 2017.
